BACKGROUND

TAZAMA Pipelines Limited was established by the Government of the United Republic of Tanzania and The Government of the Republic of Zambia on ownership of 1/3 and 2/3 in 1966 for the purpose of transporting Petroleum Products from Dar es salaam, Tanzania to Ndola, Zambia. This existing TAZAMA Pipeline was Commissioned in 1968 to transport Petroleum Products.

The pipeline is owned and operated by TAZAMA. The pipeline is approximately 1,710KM in total length (927km in Tanzania and 783 km in Zambia) comprising of 954 km of 8'' and 798 km of 12'' sections and is fed by an oil terminal storage tank farm at Kigamboni and flow sustained using Seven (7) pump stations along the route.

TAZAMA Pipelines Limited intends to award a project developer for undertaking project financing, designing construction, testing and commissioning of the new Multi-Product Petroleum Pipeline and the Rehabilitation of the existing TAZAMA Pipeline. In this regard, the Company seeks to engage a consultant firm to provide transaction advisory services.

1. TAZAMA Pipelines Limited (TAZAMA) invites sealed Technical and Commercial proposal from interested service providers to provide consultancy services to the Government of the United Republic of Tanzania, the Government of the Republic

of Zambia and TAZAMA Pipelines Limited for provision of Transaction Advisory services regarding the;

- I. Financing, Designing, Developing, Construction, Commissioning, Operation, Management and Transfer of the Refined Multi-Petroleum Products Pipeline from Dar es salaam in the Government of the United Republic of Tanzania to Ndola in the Government of the Republic of Zambia and;
 - II. Financing, Designing and Upgrading the existing TAZAMA Pipeline which is currently transporting Low Sulphur Gas Oil (LSG) from Dar es Salaam in the Government of the United Republic of Tanzania to Ndola in the Government of the Republic of Zambia.
